TENDER NOTICE

1. Sealed tenders are hereby invited by InterContinental Dhaka (Pre-opening) for **Supply, Installation, Testing and Commissioning of Lifting up RMS Room, Gas Connection of Boilers & kitchen Areas with all Accessories at Intercontinental Dhaka at 1 Minto Road, Dhaka-1000**, from only-enlisted Firms of Titas Gas who have experience in similar type of works.
2. The intending Firms must fulfill the following minimum eligibility criteria:
 - (a) The Firm(s) having experience in implementing similar nature of job in a 5-star / 4-star hotel, hospitality industry will get preference.
 - (b) The Firms must have 5 (five) years working experience in similar nature of job in the past.
 - (c) The Firms must submit the completion certificate (issued by owner) for successful completion of similar nature of job in a single order costing not less than Tk.10,00,000.00 (Ten Lac) during the last five (5) years.
 - (d) The Firm must have a minimum average annual turnover not less than Tk.50,00000.00 (Fifty lac only) during last 3 (three) years.
 - (e) The Firm must have an income tax clearance certificate for the financial year 2015-2016 & TIN No. and VAT registration certificate.
 - (f) The Firm must have up to date trade license.
 - (g) The Firm must be of class 1.3 and must have Titas Gas Company enlisted certificate.
 - (h) The Firm must have at least 01(one) number welder with minimum B grade certificate.
 - (i) The Firm must have at least 01(one) number fitter with minimum B grade certificate.
3. The tender documents containing the terms & conditions will be issued only to the eligible firms who will fulfill the criteria mentioned in Para-2 above on payment of Tk.1, 000.00 (Taka one thousand) only (non-refundable) in cash from the office of the undersigned during office hours from 18-05-2017 to 30-05-2017.
4. Earnest money amounting to Tk.1,00,000.00 (Taka one lac only) in the form of Bank draft / Pay order from any schedule Bank of Bangladesh located in Dhaka issued in favour of Ruposhi Bangla Hotel shall have to be furnished along with the tender without which the tender shall be rejected outright.
5. A Pre-bid meeting with the intending bidders who will have purchased the tender document will be held on 25 May, 2017 at InterContinental Dhaka.
6. The tender will be received in the office of the undersigned, up to 4:00 pm on 01 June, 2017 and the same will be opened at 4:30 pm on the same day at the same place in presence of the tenderers' representatives who may like to remain present.



In addition to the above soft copy submission, two sets of hardcopy of Tender with Earnest Money must be submitted in a sealed envelope **within 24 hours** of the closing date and time as nominated above.

The Tender Proposal envelope must contain the hard copy of Earnest Money **without which tender shall be rejected outright**.
